This agreement establishes the responsibility of District 75, parents, and students regarding the rental/loan of school owned band instruments. This agreement commences when the student takes possession of the instrument to the time it is returned on the first day of school.

### Responsibility of the School District:

- regular maintenance of instrument (inevitable wear of the instrument)
- instrument is issued in working condition and free of major damage
- Oil / slide grease are issued with the instrument
- supply instrument with mouthpiece (for a rental fee) if you do not own your own-although students are encouraged to buy their own

### Responsibility of the Parents:

- monitor your child's treatment of the instrument (see below)
- pay the rental/loaner fee for the year
- pay for any repairs or damages that occur as a result of your child's treatment of the instrument
- return the instrument free of damage by the requested date
- maintain instrument for student to practice on at home if needed

### Responsibility of the Student:

- use the instrument with extreme care in every situation (make sure it fits properly in its case, handle it gently even when it's in the case, use caution when putting it together, be careful not to bump into anything and keep and keep a tight hold on it when moving around the room)
- store your instrument in its proper locker and keep this space clean and neat
- take care of your instrument by keeping it clean, neat, and free of damage
- maintain the condition of the instrument by using grease and oil as needed and cleaning the instrument after use
- you are the only one who is to touch the instrument
- pay for any repairs or damages that occur as a result of your treatment of the instrument (this includes all dents and dings!)
- return the instrument/ mouthpiece free of damage by the requested date
- replace the oil and slide grease if needed

- return the instrument free of damage by the requested date
